Palm Resaca Mobile Home Park, Inc. (PRMHP) is a privately owned, no pet, independent living community for people ages 55 and over. Acceptance for membership in the Corporation authorizes you to either move an approved mobile home onto a vacant space in the park or to purchase a home that is for sale in the park.

Residency is restricted to up to two people in a mobile. This may consist of two members or a member and a Membership Committee approved non-member. A shareholder's spouse/partner who is under 55 may apply for an age exemption from the Membership Committee.

A shareholder who resides alone, and receives prior approval from the Membership Committee, may have one approved adult, over 55, non-member live with him/her on a non-fee basis. If the status of the residents in a mobile change, the office must be notified, (i.e. the addition of a significant other in the mobile.)

This application is your primary opportunity to provide information that will be used to either ACCEPT or DENY membership without comment. Both persons who propose to **reside** in the mobile in the Park need to apply and fully complete the information in this application. **Both applicants should provide complete and candid answers. Failure to complete any section may make the application subject to denial**.

Application for membership also requires an interview with one or more members of the Membership Committee. This

interview may be conducted in person or by telephone.

| • | The Board of Directors reserves the right to suspend park privileges of any resident for cause, or who refuses to comply with the By-Laws, Rules and Regulations or other documents that govern Park operation. |
| • | Operation and maintenance (O&M) fees and rents are due on the first (1st) of each month. A late fee will be assessed for each month O&M fees are received after the fifth (5th) of the month. |
| • | The Mobile Home Improvement Committee (MHIC) must approve all work prior to being started to include: all outside improvements, modifications, and major repairs to homes, carports, awnings, cabanas, enclosures, storage structures, home additions of any kind, air conditioner/heat pump installation or repositioning and planting of trees or shrubs. An application for approval and the guidelines are |

- Anyone staying in the park who is not a resident: a member (shareholder), an approved non-member or renter, is considered a guest. Your guests are your responsibility. All guests must be registered and paid for. See Rules and Regulations for more information.
- All mobile homes offered for sale within the Park must be listed with the Office. All purchasers must submit an application to, and be approved by, the Membership Committee before the sale can proceed. An owner may have his/her home sold to a member of the immediate family, a neighbor, or personal friend subject to the Palm Resaca Corporation By-Laws. The Park Manager is responsible for completing the sale on behalf of the Corporation. The seller will pay a Transfer Fee of 5% of the home purchase price to the Corporation.
